<p><b>Marriage/Civil Partnership</b></p> <p><i>Married couples and civil partnership should be treated the same on a wide range of matters</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>

<p><b>Race</b>  <i>Refers to a group of people defined by their race, colour and nationality (including citizenship) ethnic or national origins</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>
<p><b>Sexual Orientation</b>  <i>A persons sexual and/or romantic attraction to other people, or lack thereof</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>
<p><b>Disability</b>  <i>A physical or mental impairment which has a substantial and long-term adverse effective on a person's ability to carry out normal day-to-day activities</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>
<p><b>Gender identity/ reassignment</b>  <i>The process of transitioning from one gender to another (can include changing names, pronouns, dressing differently, medical intervention and living in their self-identified gender)</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>
<p><b>Pregnancy/maternity</b>  <i>Refers to being pregnant and the period after birth (linked to maternity leave in the employment context)</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>
<p><b>Religion or Belief</b>  <i>Religious and philosophical beliefs, including lack of belief (atheism)</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>
<p><b>Sex</b>  <i>Gender assigned at birth</i></p>	<p><i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i></p>

<b>Employment or Trade Union Membership</b>	<i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect. The award is designed to support those currently working in relevant industries to develop their skills, underpin their knowledge and provide evidence of competence in their chosen subject.</i>
<b>Past Criminal Convictions</b>	<i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i>
<b>Poverty or Deprivation</b>	<i>Adults meeting the eligibility criteria will be supported to access and achieve the award without risk of discrimination either direct or indirect.</i>
